We will hear from a range of speakers including presentations from clinical professionals, third sector leaders, and people who have lived experience of stigma.

Previous NHS APA conferences have attracted Directors of Public Health, Substance Misuse workers, Public Health Commissioners, ICS/PCN (previously CCG), Drug & Alcohol Recovery Managers, Directors of Operations, Senior Managers & Decision Makers, Partnership Coordinators, Behaviour Support Managers, Academics, Health Sectors, Local Authorities, Voluntary Sector, Treatment Funders, Researchers and Policy Makers.

The conference will address:

- How we can challenge and reduce the impact of stigma in services and in society;
- How we can educate ourselves and others on issues related to stigma;
- The impact of stigmatising language on people living with addiction, and how we can address it.

Within the programme of events for this year's conference, a number of sponsorship packages are available.

Last year's conference saw global attendance from over 500 delegates, and this year we are expecting attendance from an even larger audience of 700 - 1000 delegates.


A package 3 or 4 sponsor page could look like this, fully customised to your organisation's brand colours and products.

Level 4 sponsors will be able to sponsor a specific session and customise a promotional offer which will appear at the end of that session to all delegates, similar to the screenshot below.





# **Terms and Conditions**

The NHS APA is a not for profit organisation and operates a fair policy with regard to sponsorship. Organisations wishing to sponsor the conference will be reviewed and assessed in terms of the NHS APA's ethical guidelines and standards prior to sponsorship being agreed.

Sponsors will have no input into any aspect of the conference design, development or delivery and no access will be granted to conference speakers, organisers or leaders outside that stated in each specific sponsorship package. Sponsors will have no influence or input into the content of the conference.

Sponsors are free to register as delegates and participate in the conference as such. However, when participating in the conference as a delegate, sponsors will not be permitted to canvas other delegates to influence them to view any specific sponsorship assets or participate in any external webinars. Delegate participation in these activities must be of their own volition.

The sponsorship packages offered are productised and limited in terms of customisation per sponsor. Legal or requested changes to the sponsorship offer will be reviewed but cannot be guaranteed.

The NHS APA offers no exclusivity rights to sponsorship of the conference.

Package 4 sponsors can choose to sponsor specific elements of the programme, this will be offered on a first come, first served basis.

There will be a fixed deadline of the 11th of October for all assets to be provided to the conference organisers.
